**THE UNDERSIGNED HEREBY AGREES AS FOLLOWS:**

1. That all required fees and charges will be paid before work is started.
2. To furnish a PERFORMANCE BOND as specified in SECTION 185-12 and a CERTIFICATE OF INSURANCE as required in SECTION 185-13.
3. Work WILL NOT interfere with proper drainage of the street.
4. All work will be properly guarded with suitable barriers, signs and lanterns and otherwise will take all precautions for the safety of the public.
5. If the work will affect the use of properties abutting or adjoining the project or subsurface installations in the vicinity of the proposed opening, the undersigned agrees to present evidence in affidavit form that he/she has served notice to the owners, tenants such properties or subsurface installations.
6. All excavated materials will be carted away. The trench or excavation MUST BE backfilled in layers not exceeding 6 inches in depth. Backfill materials shall be well moistened and tamped  $\frac{3}{4}$ " stone and dust or bankrun gravel with no stone more than 6 inches in diameter and no shale rock.
7. At least one day prior to backfilling and installation of pavement, the Department of Public Works MUST be called for an inspection; 9073-694-6100.
8. Permanent pavement WILL consist of 4 inch Quarry Process Stone base, 4 inch Bituminous Stabilized Base Course and 2 inch FABC Mix I-5 Surface Course.

13. To indemnify and save harmless the BOROUGH OF LINCOLN PARK from and against any and all loss, costs or damages incurred by reason of any damage to any property, injury to any person, or any loss of life resulting from any negligence of the applicant, his agents, servants or employees in performing the work covered by this permit.
14. To comply with ALL BOROUGH ORDINANCES, specifically Article III, Openings, Excavations, etc. (attached).
15. To CALL BEFORE YOU DIG (1-800-272-1000) for Utility locations.
